## PRESIDENT'S MESSAGE

It's Saturday morning, July 4th, and it does not look like it is shaping up to be a very nice day for BBQs. Looks kind of dreary outside, just like the atmosphere surrounding some in this community. I know that a bunch of you did not agree with the decision to not open the pool as yet, but the Board of Trustees, whom you elected to represent this community, has acted and will continue to act in the best interests of everyone, not just the disgruntled handful that continue to spread rumors and try to cause dissention here at Lions Head South. I have tried my best to explain our reasoning in robo calls and my messages here, but to no avail. The list of rules for opening amenities are so complex and prohibitive that we just can't comply. Not because of money as some might suggest, but due to the lack of trained personnel and or volunteers.

Included in this issue is a communication from our attorney with information concerning Covid 19 and pool openings. Please read carefully and you will see that we are in a very difficult position on this matter. We all stand to lose everything personally and as a community if someone gets sick and decides to sue. Also, our insurance carrier has already told us they will not cover us in the event someone gets sick from using the amenities. All over the country this virus is taking its toll. Numbers are rising instead of dropping and states are rolling back on opening up to "normal" activities. Every one of us knows someone who has contracted this horrific virus. I am not trying to be an alarmist, but to act cautiously with the Board on your behalf.

Another thing that needs to be addressed is the subject of robo calls. Please make sure you are included on the call list and listen to the calls as they come in. It is important as this is the only communication you have with the "facts" as they are presented. Things change and notifications are sent via robo call and if you are not on the call list then you have to rely on some other "source" for information, which may not be accurate. Robo calls are only done once a week and are not intended to "interrupt" your life but to keep you informed. This does not mean that you call the office after every robo call to find out what the call meant. The only other time a call will go out is if I have a special announcement that can't wait until Sunday's weekly call. Please call the office if you need to be added to the call list and speak to Ann who will make the change.

As always please be safe, follow social distancing as best you can, and be patient and aware as this will eventually pass.

# GARDEN CLUB

As with many of our committees, we have not been able to meet so there is nothing new to report. However, we have continued with our watering schedule and even though you are not enjoying the pool, the flowers we planted within the pool area as well as the pots throughout the community have been carefully cared for by our members and they are thriving.

Now is the time of year when your petunias and verbenas may be getting leggy so don't be afraid to trim them so they can fill in. August is also a good time to check your trees and shrubs. Gypsy moth egg masses may begin to form and should be removed and destroyed before they destroy your tree. Butterfly bushes and Rose of Sharon bushes should be deadheaded to prevent seed production. Roses should be fertilized early in the month for the last time this year. Control any fungal diseases with appropriate sprays. Additionally, when replacing plants remember to do so with native plants which encourage native pollinators to visit and are usually more drought and disease resistant.

### AVOCADO BREAKFAST BAKE....recipe from the collection of a neighbor in LIONS HEAD NORTH.

6 medium avocados  
6 eggs  
5 slices of cooked bacon, crumbled  
1 1/2 cups shredded cheddar cheese (fat free for a healthier option)  
salt & pepper

Preheat oven to 425 deg. F.

1. Begin cutting the avocados in half & remove the pits.



## KEEP YOUR PERSONAL HEALTH INFORMATION SAFE

Americans are spending more time at home, which means they are likely spending more time online. While their attention is focused on staying healthy, they shouldn't forget to stay vigilant about cybersecurity either. Bob Davis, deputy chief information security officer at Cigna Corporation, has a few simple steps to protect individuals and their families from internet and phone threats.

-Never open email or attachments from unknown senders. Many scams occur when clicking on fraudulent links or attachments in emails.

-Guard personal information. As a general rule, health insurers will never ask for credit card information or account passwords in an email. Report emails asking for this information to your health insurance company immediately.

-Hang up and call back. Not all threats occur online. Be wary of phone calls from someone claiming to be your health insurance company asking for personal information. To confirm legitimacy, simply hang up and call the customer service phone number listed on the back of the insurance card.



Scammers are using this time to cheat you out of money you can't afford to lose. Someone pretending to be from your utility company might call or visit in person and demand payment then and there. Utility companies always send letters about your payment status and would rather work out some sort of payment schedule than shut off your utilities. So, beware of the following:

-Scammers might call and say you overpaid and ask for banking information, claiming to send the refund directly to your bank account. It's a lie. Don't give out any financial information about your bank account.

-Utility companies do not call and ask you to pay by gift card, wire transfer or any other unusual form of payment.

Don't be frightened by these scammers, even if they threaten to cut off your utilities. They're using scare tactics. Don't be fooled!

## BE AWARE OF SOCIAL SECURITY SCAMS

Social Security phone scams are the #1 scam reported to the Federal Trade Commission. The best way to protect yourself and your money is to recognize a scam. Scammers use intimidating language and often offer a "solution" to the problem. How can you tell when it's a scam?

Social Security will NOT:

-Say your Social Security number has been suspended.

-Promise a Social Security benefit approval or increase in exchange for information.

-Call to demand an immediate payment.

-Insist you pay a debt without the ability to appeal the amount you owe.

-Require payment by retail gift card, pre-paid debit card, internet currency, wire transfer, or by mailing cash.

-Ask for your personal information.

What should you do if you receive a suspicious call?

-Hang up!

-Don't share personal information or make a payment.


-Report the scam to the Social Security Administration's Office of the Inspector General at <https://oig.ssa.gov>.

## **IT'S BEST NOT TO OPEN YOUR POOL**

We continue to recommend against Associations opening the pool for the following reasons:

1. COVID-19 is still with us. Despite positive progress, new cases and new deaths are reported every day.
2. Some states which either did not have as restrictive “stay at home orders” or which lifted their restrictions earlier than New Jersey are experiencing an increase in cases and deaths. A joint advisory was issued on June 24th indicating that those arriving in New Jersey from Alabama, Arkansas, Arizona, Florida, North Carolina, South Carolina, Washington, Utah, and Texas quarantine for 14 days from the time of last contact with one of these states.
3. The Association Board prioritizes the lives, health, and safety of the residents. According to CDC, deaths associated with COVID-19 have disproportionately impacted those 65 and older and those with other health issues. The Association has many residents 65 and older and many residents with other health issues.
4. Although Governor Murphy’s Executive Order 153 allowed pools to be used as of June 22, 2020, such use was made contingent upon complying with extensive and expensive regulations. Among other things, these regulations would require hiring two to three people in addition to the lifeguards to: 1) serve as “pool ambassador” to ensure regulatory compliance; 2) serve as an “access checker” to sign people in an out and attempt to check for obvious signs of illness and 3) serve as additional janitorial service to implement “enhanced sanitation”.
5. Although the Association maintains broad insurance coverage, the Association’s insurance broker has advised that the Association’s carriers will attempt to disclaim coverage of all COVID-19 related claims.
6. If COVID-19 claims are asserted against the Association and the Association’s insurance carriers refuse to defend the claims with insurance company lawyers, the Association will have to pay out of its own funds to defend the claims. These claims could cost between \$100,000 and \$250,000 or more to defend. The Association would likely have to pay these legal bills via a special assessment spread over all homeowners.
7. If COVID-19 claims are asserted against the Association, the Association’s insurance carriers refuse to cover the claims and the Association is ultimately found liable for damages etc., the Association will have to pay the damage amount out of its own funds. Potential liability amounts are impossible to estimate. The Association would likely have to pay these liability amounts via a special assessment spread over all homeowners.
8. Waivers, release, hold harmless agreements and agreements not to sue are helpful but they do not provide complete insulation from claims or liability. Although New Jersey courts have upheld certain releases they have also disregarded them in seemingly similar circumstances. This is especially true where a person who did not sign a release is injured (ex. a husband signs a release, allegedly contracts COVID-19 at the pool, his wife also contracts COVID-19 but has never signed a release or used the pool) and where children/minors have allegedly released a party.
9. Claims with respect to transmission of disease are not new, courts have allowed them to proceed. Cursory research reveals the 1953 case of Earle v. Kuklo, 26 N.J. Super 471 (App. Div. 1953). The Kuklos owned a two-family house. Mr. and Mrs. Kuklo and their daughter lived in the first-floor unit. Mr. and Mrs. Earle rented the second-floor unit. Shortly after moving in, the Earles’ daughter, Bonita, was born.

The Earles sued the Kuklos claiming that the Kuklos had tuberculosis, that the Kuklos knew they were infected before the Earles moved in, that the Kuklos failed to tell the Earles about their tuberculosis and that the Kuklos did not “abstain from close personal contact with the Earles” thereby transmitting tuberculosis to baby Bonita. Baby Bonita apparently became very ill and suffered a long hospitalization.

The Trial Court dismissed the case but the Appellate Court reversed, noting various duties specific to tuberculosis and adopting the principle that “a person who negligently exposes another to an infectious or contagious disease, which such other thereby contracts, is liable in damages therefor. . . The degree of diligence required to prevent exposing another to a contagious or infectious disease depends upon the character of the disease and the danger of communicating it to others. To show negligence in exposing another to a contagious or infectious disease, it must be proved that the defendant knew of the presence of the disease.” There are many facts that distinguish Earle v. Kuklo from Associations dealing with COVID-19, but the case provides no comfort.

10. New Jersey Plaintiffs’ attorneys have already taken steps to pursue COVID-19 claims. On June 15, 2020, Charles Toutant of the New Jersey Law Journal reported that Tort Claims notices have been filed with respect to Veterans’ Homes in Menlo Park and Paramus, New Jersey claiming, among other things, that the facilities “recklessly endangered the safety and well-being of patients and staff by failing to promptly implement appropriate measures, such as infectious disease outbreak plans.” Most of the claims relate to COVID-19 resident deaths but others relate to employees and family members of employees who got COVID-19. The Plaintiffs’ attorneys “have estimated damages at \$5 million for each case.” Proving causation may be difficult or impossible and damage claims may be speculative, but these claims demonstrate that there are plaintiffs and plaintiffs’ attorneys willing to pursue COVID-19 claims.

The Board must reasonably weigh the benefits versus the risks of opening the pool. Again, we recommend against opening the pool.




